

A LEVEL LAW

Course Overview

The law underpins everything we do. Studying law at A level enables you to understand how your country works and how we are governed. You will develop a greater understanding of the English Legal System, Criminal Law, Civil Law and Contract law. You will analyse murder cases, property offences and non-fatal offences whilst also considering the legal defences that might be available to the defendant in court.

Course Content

In Year 12, you will study the foundations of the English Legal System such as courts, criminal custodial sentences and the people who work in the justice system. You will also study Criminal Law, including the offences of murder, manslaughter, robbery and theft. In Year 13, you will study the Civil Law of Torts such as negligence and many other reasons someone can sue another in court. Finally, you will study Contract Law, including the terms that make up a contract and what happens if a contract is breached.

Skills Developed

The study of law improves your powers of reasoning, clarity of thought, analysis skills and allows you to evaluate the law. You will build a knowledge of cases and statute and have an excellent understanding of what Parliament does.

Educational Visits and Opportunities

- Our biggest trip is to London for 2 nights! We will visit the Houses of Parliament, the Royal Courts of Justice, The Supreme Court and much more.
- 2. We visit Preston Crown Court where the most serious criminal cases are heard in the Northwest. Here you will meet judges, visit the cells and watch live trials in action.
- 3. Barrister in Residence! Many of our ex-students have joined the Bar and become barristers so we always ask one to come and visit to talk to our students.
- 4. Mock Trials we have a very successful history of mock trials so why not polish up your public speaking skills and have a go at preparing a criminal case for court!
